Dear Mr. President-elect:

As leadership of the House Gun Violence Prevention Task Force, we congratulate you and Vice President-elect Kamala Harris on your victory and we look forward to working with you to build a safer and more secure America. While our communities have been devastated by the Coronavirus pandemic, we are also experiencing a silent public health crisis of gun violence. Despite the pandemic, gun violence is at unprecedented levels, with more than 570 mass shootings and more than 16,800 people killed this year. We will need respected and seasoned leaders within the Administration to address these crises.

The Bureau of Alcohol, Tobacco, Firearms and Explosives (ATF) is the first line of defense in the effort to end gun violence. This includes advising members of the U.S. Senate on coronavirus response, work place safety in the private sector, and development of educational curriculum around injury prevention.
